#### Impact on Foster Youth

- Lower rates of educational attainment
- Higher rates of behavioral health challenges
- Higher risk of homelessness
- High levels of resiliency



#### YOUNG ADULTHOOD LOOKS DIFFERENT FOR YOUTH LEAVING FOSTER CARE



## Foster youth face young adulthood without the financial or emotional support of an extended family.







#### Transitional Housing Program-Plus (THP-Plus)

#### What's provided:

- 36 months of free or deeply subsidized housing
- Provider usually subleases unit to youth, often with roommate
- Supportive services and monthly stipend provided

#### **Eligibility:**

- Age 18-24 (not yet 25)
- Exited foster care or out-of-home probation on or after age 18
- Working toward goals in Transitional Independent Living Plan

#### Program capacity:

- More than 1,600 youth served at a moment in time
- 47 of California's 58 counties have programs

#### **Housing Vouchers**

#### What's provided:

- 3-5 years of subsidized housing
- Youth is directly on the lease, no roommate
- Supportive services provided

#### **Eligibility:**

- Age 18-24 (not yet 25)
- Exited foster care or out-of-home probation or will exit within 90 days
- To extend voucher
   2 years, must be
   working or in school

#### Program capacity:

- More than 2,000 youth served at a moment in time
- 33 of California's 58 counties have programs in partnership with local Public Housing Authorities

#### The Foster Youth Tax Credit (FYTC)

provides a refundable tax credit to current and former foster youth who file their state taxes.

In 2025, the credit is \$1,154.

#### Eligibility


- Between age 18-25 on last day of tax year
- Was in foster care on or after 13<sup>th</sup> bday
- Eligible for CA Earned Income Tax Credit (earned \$1-31,950 in tax year, lived in CA more than half of tax year, has SSN or ITIN)



2025-2030




