2025 Updates: Expanded Expedited Removal

 Expedited removal —process where ICE can deport someone without going through the immigration court process

LOCATION

<u>Before</u>: only at or near port of entry (airport, border)

Now: everywhere in the US

DURATION

<u>Before</u>: only those who entered in the last 14 days

Now: those who EWI <u>and</u> less

than 2 years in US

Remember

- Two ways someone could be undocumented
 - EWI ⇒ entered without inspection
 - Visa overstay ⇒ entered with a visa and stayed beyond the allowed duration of stay

Those who EWI could be at risk of expedited removal

2025 Updates: Expanded Expedited Removal

LOCATION

Before: only at or near port of entry (airport, border)

Now: everywhere in the US

DURATION

Before: only those who entered in the last 14 days

Now: those who EWI and less

than 2 years in US

For those who had EWI: If possible, have documentation showing two years of physical presence in the United States with them at all times.

2025 Updates: Laken Riley Act

- Mandatory detention for certain undocumented persons who were arrested or charged with certain offenses:
 - shoplifting
 - o theft
 - burglary
 - larceny
 - o assault on a law enforcement officer
 - any crime that results in death or serious bodily injury
- There are other provisions of this new law not covered here

2025 Updates: TPS

Temporary Protected Status (TPS)

- DHS may designate a foreign country for TPS due to certain conditions there
 - E.g. armed conflict
 - E.g. earthquake or other disasters

Temporary

- 18 months
- DHS can extend

2025 Updates: TPS-Designated Countries

Re-registration period open:

- El Salvador
- Haiti (period shortened!)
- Honduras
- Nepal
- Nicaragua
- Sudan
- Ukraine

Other countries under TPS:

- Afghanistan
- Burma (Myanmar)
- Cameroon
- Ethiopia
- Lebanon
- Somalia
- South Sudan
- Syria
- Venezuela (2023)

2025 Updates: Alien Registration Requirement

- Requires noncitizens to register with the federal government and:
 - provide their fingerprints
 - provide their address
- The process for registering is now at the USCIS website
- Criminal penalties might apply to those who refuse to register

Individuals should talk to an immigration attorney BEFORE filling out any form. This could be used for enforcement.

2025 Updates: Alien Registration Requirement

According to the **ILRC**:

- The US government last used a register after 9/11
 - Required men from Muslim countries to register
 - The register was in place from 2002 to 2016
 - Thousands of men who registered were deported

Individuals should talk to an immigration attorney BEFORE filling out any registration form.

2025 Updates: What do we do?

At the personal level: emotional regulation

2025 Updates: What do we do?

In our place of work:

- Develop policies in the event of an ICE encounter:
 - What service spaces are non-public? Consider putting appropriate signage.
 - Who is the person in charge of responding to an ICE agent?
 - o What is the organization's policy for non-sharing of information with ICE?

2025 Updates: What do we do?

As we do our work:

Do not ask about anyone's immigration status.

- Acknowledge fears, but don't further fuel them.
- Empower by providing resources and support.
 - If someone express fears of an ICE encounter, share Rapid Response resources (see slides under Resources).
 - Have immigration resources easily accessible.

A note about UPL



Unauthorized practice of law (UPL)

→ someone gives legal advice without a license

UPL:

- Asking questions = OKAY
- Giving referrals or resources = OKAY
- Giving information or advice = NOT OKAY



2020 COVID Rapid Response







The City of Fremont's Family Resource Center works to provide comprehensive support to families in need, offering a range of services from financial assistance to mental health and wellness programs. Our center is a vital community hub, empowering families, particularly immigrants and low-income residents, to build self-sufficiency and thrive in a supportive, **collaborative environment.**



Strengths in Supporting Immigrants in the Tri-City Area

Fremont, Newark, and Union City

- •Diverse, Culturally Sensitive Services: A wide range of community organizations and local institutions offer tailored services to immigrant populations, including legal aid, social services, and language access.
- •Established Non-Profit and Government Collaboration: Strong local organizations, such as Fremont Family Resource Center, the Union City Family Center and IIBA, provide critical resources through family support assistance, like case management, financial coaching, and community integration programs.
- •Collaborative Community Engagement: The Fremont Family Resource Center brings together over 20 state, county, city, and nonprofit social services agencies who work collaboratively to conduct targeted community outreach and provide comprehensive support, while fostering a strong sense of community for immigrants.



Gaps in Supporting Immigrants in the Tri-City Area

Fremont, Newark, and Union City

- •Language Barriers: Limited availability of services in underrepresented languages, particularly for populations from regions like Afghanistan or Latin America.
- •Affordable Housing: he Tri-City area's housing crisis severely exacerbates the struggles of immigrant families, with persistent barriers such as discrimination and a lack of resources for undocumented individuals, leaving them increasingly vulnerable—even amidst recent affordable housing developments in Fremont.
- •Access to Legal and Mental Health Services: The overwhelming demand for immigration legal aid and mental health support far surpasses available resources, leaving countless immigrants without essential assistance, trapped in a state of fear and insecurity



Empowering Immigrants with Financial Resources for Security

FINHABITS

Financial Services for Immigrants: FinHabits is a digital financial platform designed specifically to serve immigrants, offering products like **savings accounts** and financial tools tailored to those without traditional credit histories.

Credit-Building Programs: FinHabits helps users **build their credit** by reporting on-time payments to major credit bureaus, empowering immigrants to improve their credit scores and gain financial stability.

No SSN Required: Users can access FinHabits' services without needing a Social Security Number (SSN), making it an accessible resource for undocumented immigrants to manage finances and build a financial foundation



Inclusive Financial Services: Patelco Credit Union offers a range of financial products, including savings and checking accounts, loans, and credit-building tools, to immigrants and underserved communities.

Low Fees and Competitive Rates: Known for offering low fees and competitive interest rates, Patelco provides a more affordable alternative to traditional banks, helping members manage their finances more effectively.

Credit Building and Financial Education: Patelco offers resources like financial counseling and credit-building products that help immigrants and low-income families improve their financial literacy and credit scores.

Certifying Acceptance Agent (CAA)

We are authorized by the Internal Revenue Service (IRS) to assist individuals who need an ITIN (Individual Taxpayer Identification Number) but are unable to obtain a Social Security Number (SSN). CAAs help immigrants and other non-residents navigate the ITIN application process by certifying their identity and documents, which is a critical part of applying for an ITIN
